Using the Traditions:

For about a year now, one of the meetings I attend has been wrestling with the issue of DA's Steps and Traditions specifically referring to God and Higher Power in male-gender terms (i.e., "Him" in Steps 3 and 7, "Him" and "His" in Step 11; and "He" and "Himself" in Tradition 2). Some members of the group see these terms as discriminatory, exclusive and/or, at the least, Some members feel the references undercut the spirit of finding one's own Higher Power as they suggest that any concept of a Higher Power must be in the form of a male being. Some members feel triggered by hearing God referred to in male-gender terms. Some members feel that in a program focused on valuing ourselves, it is important for everyone to be equally valued equally and the male references in the Steps and Traditions preclude this.

Other members feel that the Steps and Traditions were adopted from AA and should be used in their original form as the foundation of our fellowship. Some members feel that if people are triggered by the male-gender references, they can and should work that out in their individual Some members feel that if any step work. changes are made to the wording of the Steps and Traditions, it opens the door for anyone to rewrite the Steps and Traditions and alter the foundation of our program. Still others feel that, while they might like to see the male-gender references changed, they feel that change should only come from the DA World Service Organization.

Currently the meeting uses a modified version of the Steps and Traditions that changes the "Him" to "God" in Steps 3, 7 and 11; the "His" to "God's" in Step 11; and "as He may express Himself" to "as may be expressed" in Tradition 2. The group conscience approved this modified version provided that the changes were specifically noted in footnotes so that people could see exactly what was changed from the official version. The meeting also adopted a preamble to the Steps that states that the Steps and Traditions were modified by the group conscience vote of the meeting in order to have gender neutrality. Some members feel that this modified version should not be permitted at all because it is not the official DA World Service version.

The business meeting discussions have at times been very respectful, thoughtful and illuminating and at other times very heated and emotional. The group has yet to find any clear answers and today the discussion continues. But the saving grace has been that members know that the Traditions are where we need to turn to inform our discussions.

Some of the traditions we have looked to in these discussions are:

<u>Tradition 1</u> – Our common welfare should come first; personal recovery depends upon D.A. unity. If a group uses a version of the Steps and Traditions other than that authorized by DA World Service, does that undermine the unity of DA as a whole? If a group uses the official DA version when members feel discriminated or excluded by the male-gender references, does that undermine the unity of the meeting and interfere with people's ability to achieve personal recovery?

Tradition 2 – For our group purpose there is but one ultimate authority--a loving God as He may express Himself [may be expressed] in our group conscience. Our leaders are but trusted servants; they do not govern. What happens when the group conscience as expressed in an individual meeting is different than the group conscience as expressed at the DA World Service level? Since the members representing DA at the World Service level are trusted servants and do not govern, should/must meetings follow their recommendations no matter what? vice Organization to change the language in the Steps and Traditions but change has yet to come about?

Tradition 4 - Each group should be autonomous except in matters affecting other groups or D.A. as a whole. Is modifying the Steps and Traditions to remove the Him/His language within a group's autonomy? If a meeting clearly indicates that the Steps and Traditions were changed by group conscience vote and indicates what and when the changes were made, is that enough to keep the issue from affecting other groups or DA as a whole? Does having meetings with gender neutral language in the Steps and Traditions allow people to find home meetings that they are comfortable with when they might otherwise be turned off from DA as a whole by the language in the official version?

Tradition 5 - Each group has but one primary purpose-to carry its message to the debtor who still suffers. Does using a modified version of the Step and Traditions interfere with the group's primary purpose of carrying the message to the debtor who still suffers? What do we do about the debtor who suffers because of not earning as much as her male counterpart and feels that DA supports or is at least indifferent to gender discrimination? What about the debtors who suffer because of powerful messages about money, earning, debting and spending they received because of his or her gender and needs a supportive environment to work these issues out?

While the group so far has found no easy answers to these issues, the discussion has focused the members on the importance of having traditions and using them. Perhaps if other groups have struggled with or found ways to address these issues, they could share their experience, strength and hope with their Intergroup Service Representatives and General Service Representatives so we can all learn from each other in the fellowship.

My Favorite Tradition:

For our group purpose there is but one authority – a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

It took time for me to realize how important the traditions are to me personally, and how beautiful and brilliant they are. One of my favorites is Tradition Two. Without this tradition, I most likely would not have stayed in D.A.

I have a deep distrust toward organizations that have domineering leaders who enforce harsh rules and have hefty demands of money and time from their followers. The second part of Tradition Two, "our leaders are but trusted servants, they do not govern," made all the difference for my feeling safe enough to stay in D.A.

When I came in to the rooms I was only given a warm welcome, the invitation to keep coming back, and suggestions on how to get the most out of the program. No demands were placed on me by the leadership of the meeting - no one tried to control, or pressure me or any other members of the group.

It made me feel at ease that our leaders are our equals in the fellowship of D.A., and that they are giving humble service because they want to share the gifts of the program, not for money or power. Tradition Two has been a critical piece in my recovery in D.A. – it allowed me to feel safe enough to stay and begin to use the tools, work the steps, and also give back as a "trusted servant" as well. And as a result I have received many amazing gifts of the program, and I am building a wonderful and prosperous life.

Working the Traditions:

When I first came to DA it was the Steps that intrigued me the most. Sure, we read the traditions at every meeting, but I really didn't listen to them. The Steps are written in past tense, as though I had already done them, and that didn't make them so daunting. I thought the Traditions were just a list of rules, and I know how to behave, so they seemed to be read out loud for others benefit.

I have come to know that the 12 Traditions are much more than that. They are the glue that holds our fellowship together; the commonality that we all measure ourselves by. I don't compare myself to the person sitting next to me at a meeting, I compare myself to the Traditions! And no, I do not always measure up to them, but they are the ideal that I strive for inside and outside a meeting.

I have been to meetings in my travels that did not seem "healthy" to me, and sure enough I'd come to find that they do not read all or any of the traditions at every meeting!

I realize that no group can "Work the Traditions" perfectly, but no one works the Steps perfectly
