


- 1. Disable call waiting, Press \*7

# Your Program in Action

Service is Vital to Our Recovery

We perform service at every level: personal, meeting, Intergroup and World Service. Service is vital to our recovery. Only through service can we give to others what has been so generously given to us.

Want to accelerate your recovery? Consider these service opportunities:

#### **SERVE Your Local Meeting**

When your D.A. meeting needs service, hold up your hand: welcome newcomers, set up chairs, volunteer for the role of secretary or treasurer, or sit on another D.A. member's Pressure Relief Group (PRG). While some positions have abstinence requirements, many do not. So hold up your hand—your fellowship will thank you and you'll feel great!

#### **SERVE** as an Intergroup Representative

D.A. Intergroup is a group of representatives from D.A. meetings throughout Northern California. The mission of Intergroup is to carry the message and to serve these meetings. Intergroup:

- Provides a forum for discussion between meeting representatives.
- Maintains and distributes regular meeting lists, and D.A. literature.
- Maintains a telephone information line about local meetings.
- Maintains the Northern California D.A. web site.
- Acts as a liaison between the group and the public media.
- Sponsors two recovery events each year—Do D.A. Day and Winter Lights—that are open to the whole membership.

Intergroup meets on the 4th Saturday of each month, except in November and December when the meeting is held on the 3rd Saturday. Intergroup meets at the main branch of the SF public library in the 3rd floor conference room. The meeting begins at 10:15 am and ends at 12:45.

#### **SERVE** as a General Service Representative (GSR)

General Service Representative's main functions are to carry information from the World Service Office to local meetings and vice versa, attend the annual D.A. World Service Conference and work on Conference committees. Visit the next meeting and find out about the D.A. Meditations Book, outreach to Spanish speaking communities, the Hospitals and Prisons committee and the Business Debtors Anonymous subcommittee. Meetings are held on the second Saturday of each month from 10:15 a.m. to 12:00 noon at the San Francisco Public Library Main Branch in the third floor conference room. The next meeting is February 14, 2004. Call Jack at 650-879-3261 to confirm.

# Shared Recovery

Ideas to Strengthen Your Program

#### Start a Step-Study Meeting

For the last three months I've attended a step-study meeting. It's been a valuable experience, not just for working the steps but also the planning and organizing of it. We have four people and meet every other week for an hour and a half. Interested in starting a group? Here's how we conduct our meeting:

- 1. Open with the Serenity Prayer.
- 2. Check-in, 3 minutes or so each.
- 3. Read about the step we're working.
- 4. Approximately 10-minute shares each on our step homework—usually a combination of reading and writing. We often share more than once; shorter, more frequent shares spark ideas.
- 5. Decide on the step-study exercise for the next meeting.
- 6. Close with the Serenity Prayer.

We also have agreed:

- · No cross-talk while sharing.
- · No food or beverages, so that we stay focused on the meeting.
- · Have a rotating secretary who leads three consecutive meetings.
- · Our group is co-ed. Some advised against it; so far it's working for us.
- For reading material we use the Big Book from AA and the AA 12 & 12.

We meet in one member's home, a place convenient to all. Our challenges are commitment and scheduling meetings that fit each person's schedule. A stepstudy group is a great way to deepen recovery and I highly recommend it.
